EITC/OSTC OVERVIEW

WHAT EITC/OSTC IS:

The Educational Improvement Tax Credit and the Opportunity Scholarship Tax Credit allow you to donate to Devon Prep and receive a tax credit in the amount of up to 90% of your PA State Tax liability.

EITC funds collected by Devon Prep are used as financial aid to offset tuition for families meeting certain income requirements (per PA State Guidelines).

OSTC funds are used similarly, but the family must meet income requirements and live where their son would otherwise attend a lowachieving (per PA State Guidelines) school in order to qualify for these funds.

Sample \$10,000 Tax Credit With A 2-Year Commitment

Donation to Devon Prep	\$10,000
PA Tax Credit Reduction (at 90% of contribution)	(\$9000)
Net Federal Tax Reduction for Contribution (at 37% Tax Rate)	(\$370)
Your Out Of Pocket Expense	\$670

You receive a tax credit, and Devon Prep receives a donation that helps those who need tuition funding the most. Minimal cost to you, maximum impact to Devon Prep students.

This tax credit is available to individual parents AND businesses!





WHY REDIRECT YOUR TAX LIABILITY TO DEVON PREP?

Via the EITC and OSTC Tax
Credit Program, you're able
to make an outsized impact
on the lives of current and
future Devon Prep students
and their families, and put a
Devon Prep education in the
hands of families who might
not otherwise have been able
to access one. Your donation
directly, positively, and
immediately impacts the
student body at Devon Prep.

You have the ability to help Devon Prep continue to fulfill its mission of educating its students, allowing us to enroll outstanding students who otherwise might not have the financial ability to attend Devon Prep. EITC and OSTC funding allows us to stretch our Financial Aid budget even further, benefitting more students than our budget would otherwise allow.









WHO IS ELIGIBLE TO CONTRIBUTE?

Companies and individuals are eligible to direct their tax credit to Devon Prep's Financial Aid program - 75% with a one-year commitment, and **up to 90% with a two-year commitment.**

Individuals who pay income tax in PA, as well as businesses authorized to operate in Pennsylvania who pay any of the following taxes are eligible to take advantage of the EITC/OSTC:

- Personal Income Tax
- Capital Stock/Foreign Franchise Tax
- Corporate Net Income Tax
- Bank Shares Tax
- Title Insurance & Trust Company Shares Tax
- Insurance Premium Tax (excluding unauthorized, domestic/foreign marine)
- Mutual Thrift Tax
- Malt Beverage Tax
- Surplus Lines Tax





PROCESS TO CONTRIBUTE VIA EITC/OSTC

If you have decided to utilize EITC/OSTC and donate to Devon Prep, the options to donate are as follows:

- 1. Apply via the Pennsylvania Department of Community and Economic Development website: https://www.esa.dced.state.pa.us/Login.aspx
- 2. Utilize a company such as **BLOCS**(https://www.blocs.org/taxcredit) or **Foundation for Catholic Education**(https://www.foundationfce.org/eitcostc)

These organizations help donors navigate the application process and ensure your donation is given where you intend.

WHAT ELSE YOU SHOULD KNOW

As with all decisions regarding taxes, you should work with your tax advisor before proceeding with the above process. But we do emphasize that contributing to Devon Prep via EITC/OSTC allows you to maximize the impact of your donation with (generally) minimal outlay of capital. And the funding goes to families of greatest need who are looking to provide their son the opportunity of a Devon Prep education.
